AA Mail END-USER LICENSE AGREEMENT FOR YOUNGZSOFT CO.LTD.

IMPORTANT-READ CAREFULLY: This AA Mail End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and YOUNGZSOFT Co. LTD for the AA Mail identified above.

By installing, copying, or otherwise using the AA Mail, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not install or use the AA Mail.

### 1. GRANT OF LICENSE.

Install and use the AA Mail on a single computer and make one copy of the AA Mail in machine-readable form solely for backup purposes. You must reproduce on any such copy all copyright notices and any other proprietary legends on the original copy of the AA Mail. Install the AA Mail on a storage device, such as a network server, and run the AA Mail on an internal network, provided the number of concurrent users does not exceed the number of copies of the AA Mail purchased. A copy of the AA Mail must be purchased for each such user. If you have purchased a multi-pack license for the AA Mail, such as a Ten-Pack license, or a license to make multiple installations of the AA Mail, you may concurrently use the number of copies of the AA Mail authorized by that purchase. Make copies of the End-User AA Mail and distribute those copies for use solely by yourself or personnel employed by you, or by another party, solely for its own internal purposes.

### 2. COPYRIGHT:

The AA Mail is owned by YOUNGZSOFT Co. LTD and is protected by People's Republic of China copyright laws and international treaty provisions. You may not copy the printed materials accompanying the AA Mail (if any), nor print copies of any user documentation provided in on-line or electronic form.

### 3. OTHER RESTRICTION:

THE AA MAIL AND ANY RELATED DOCUMENTATION IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTIES OR MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NONINFRINGEMENT.
